



JUDGMENT

(Delivered on 18th May 2018)

This is an inquiry under section 22 of The Maharashtra Public Trusts Act, 1950. (Herein after referred as "The Act" for sake of brevity)

2. Brief facts as under :-

The said institution is Public Trust registered under The Act having registration no. F-1344. The tenure of executive body has elapsed. So, it was required to be replaced by way of election. So on 25.02.2018 by issuing notice a meeting was called on 19.03.2018. In the said meeting, it was unanimously resolved to elect new trustees. Thus newly trustees are required to be reported to this office and entries need to be taken in concern record. Hence, this application.

3. Heard reporting trustee in person. Following points arise for determination and I record my findings along with reasons as under:-

He has also place reliance on certified copy of Memorandum of Association (Exh.6), certified copy of PTR (Exh.4), death certificate of Haribhau (Exh.7), certified copy of previous change report inq. no. 997/13, 883/14(Exh.5), consent letter of Incoming trustees (Exh.9), No objection of Outgoing trustees (Exh.10), verified copy of notice (Exh.11), Verified copy of resolution (Exh.12) and Verified copy of list of members (Exh.13).

5. The reporting trustee has reiterated the evidence as Exh.1. According to him, the change report is true and correct. 7. In view of finding of point no.1 in the affirmative hence.



- c) Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
- d) Installation of DG Set must be strictly in compliance with recommendations of DG Set manufacturer.
- e) A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would help to prevent noise levels of DG set from deteriorating with use.
- f) D.G. Set shall be operated only in case of power failure.
- g) The applicant should not cause any nuisance in the surrounding area due to operation of D.G. Set.
- h) The applicant shall comply with the notification of MoEF dated 17.05.2002 regarding noise limit for generator sets run with diesel.

1. You shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous waste to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf.

You shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.
4. Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.
5. You shall provide an alternate electric power source sufficient to operate all pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent.
6. You shall submit, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992 to Regional Office, , the 30th day of September every year.
7. 


